1. Balance of Trade

Balance of Trade showed a deficit of TZS 140,172.9 million in January 2025, increased by 18.4 percent compared to the corresponding month of 2024 and decreased by 8.7 percent compared to the previous month. The trade ratio for January 2025 is 2.8, decreased from 3.6 percent in December 2024 and from 12.4 percent in the corresponding month in January 2024 (Table 1).

2. Exports Statistics

January 2025, recorded a total exports value of TZS 4,006.2 million, decreased by 76.1 percent compared to January 2024 and by 29.9 percent compared to previous month (December 2024). Food and live animals contributed 47.5 percent (TZS 1,903.4 million) of the total exports as seen in table 2.

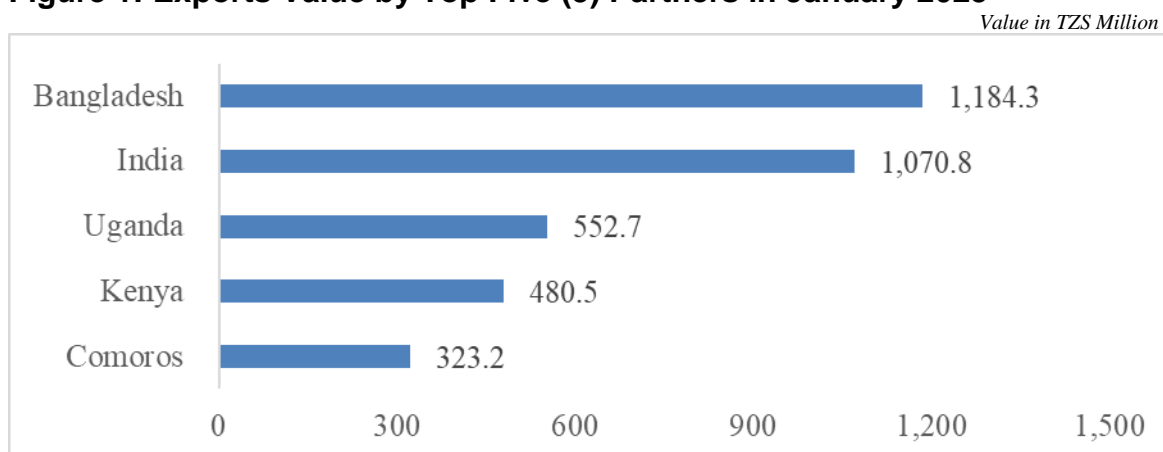

3. Exports by Top Five Partner in February 2025

The top five trading partners for exported goods in the February 2025 accounted 90.1 percent of the total value of exported goods. Major export destination was Bangladesh that accounted 29.6 percent (TZS 1,184.3 million) of the total export (Figure 1).

4. Imports Statistics

Month of January 2025 recorded a total import value of TZS 144,179.1 million, which increased by 6.6 percent compared to January 2024 and decreased by 9.4 percent compared to previous month to December 2024. Mineral fuels, lubricants and related materials section contribute 48.3 percent (TZS 69,682.6 million) of the total import value followed by Machinery and transport equipment section (12.0 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for January 2025 was TZS 27,798.9 million, which decreased by 24.5 percent compared to the corresponding month and by 36.1 percent compared to previous month. Imports value of capital goods was TZS 26,263.2 million, which increased 20.3 percent compared corresponding month and decreased by 32.6 percent compared the previous month. Imported value of intermediary goods was TZS 90,116.9 million, which increased by 17.7 percent compared to the corresponding month of 2024 and by 17.4 percent compared to previous month. (Table 4).

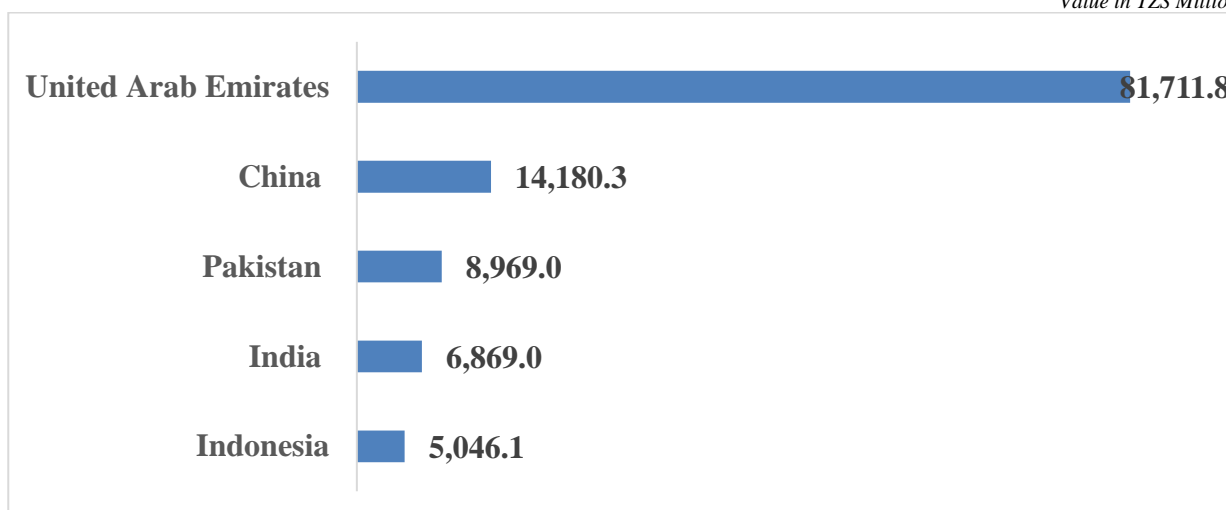
