**MONTHLY EXTERNAL MERCHANDISE TRADE STATISTICS****MARCH 2023****1. Balance of Trade**

Balance of Trade showed a deficit of TZS 106,410.1 million in March 2023, increased by 21.1 percent compared to the corresponding month of 2022 and by 15.9 percent the previous month. Trade ratio decreased from 6.5 percent in February 2023 to 6.1 percent in March 2023. (Table 1).

March 2023, recorded a total exports value of TZS 6,878.5 million, decreased by 67.2 percent compared to March 2022 and increased by 7.0 percent compared to previous month (February 2023). Food and live animals contributed 65.6 percent (TZS 4,514.9 million) of the total exports in March 2023 as seen in table 2.



### 3. Exports by Top Five Partner in March 2023

The top five trading partners for exported goods in the March 2023 accounted 71.9 percent of the total value of exported goods. Major export destination was India that accounted 33.5 percent (TZS 2,307.4 million) of the total export in March 2023 (Figure 1).

#### 4. Imports Statistics

March 2023 recorded a total import value of TZS 113,288.6 million, which increased by 4.1 percent compared to March 2022 and by 15.3 percent compared to previous month.

Mineral fuels, lubricants and related materials section 47.9 percent (TZS 54,316.6 million) of the total value imported followed by Food and live animals (17.5 percent). The performances of other sections are as shown in table 3.

#### 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for March 2023 was TZS 22,743.0 million which decreased by 36.2 percent compared to corresponding month and by 11.2 percent compared to previous month. Imports value of capital goods was TZS 15,189.3 million which increased by 0.2 percent compared to the corresponding month and decreased by 53.9 percent compared to the previous month. Imported value of intermediary goods was TZS 75,356.3 million which increased by 29.8 percent compared to the corresponding month of 2022 and by 90.0 percent compared to previous month. (Table 4).


