1. Balance of Trade

Balance of Trade showed a deficit of TZS 120,331.2 million in May 2023, increased by 48.5 percent compared to the corresponding month of 2022 and by 8.7 percent the previous month. Trade ratio decreased from 4.3 percent in April 2023 to 3.6 percent in May 2023. (Table 1).

2. Exports Statistics

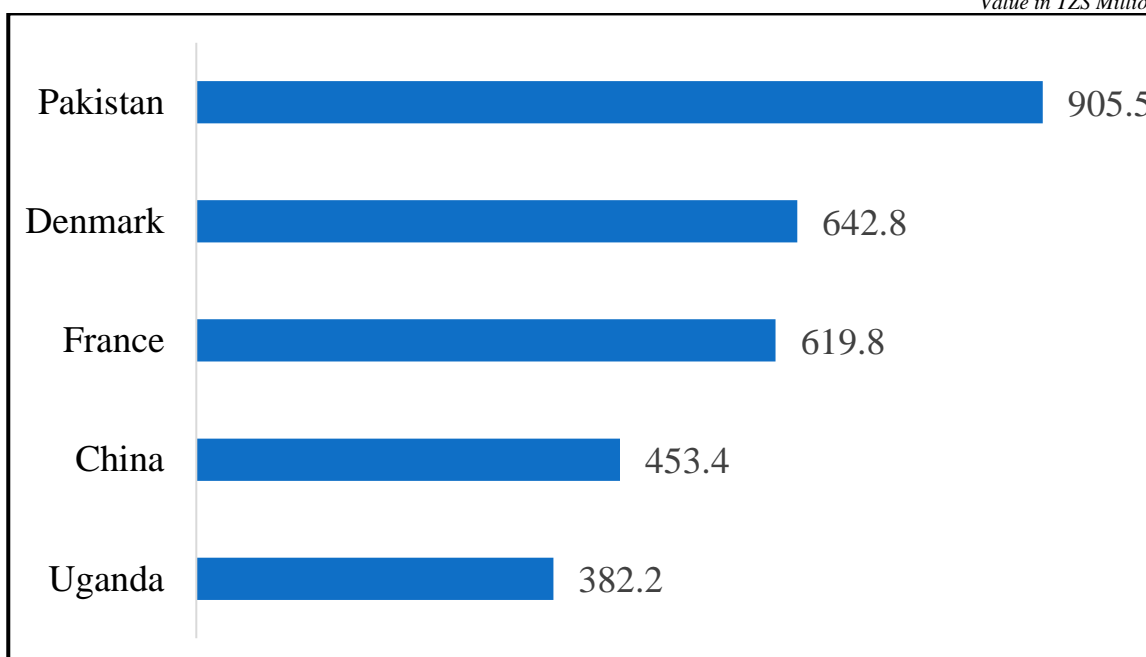
May 2023, recorded a total exports value of TZS 4,513.0 million, increased by 10.3 percent compared to May 2022 and decreased by 9.8 percent compared to previous month (April 2023). Food and live animals contributed 75.8 percent (TZS 3,420.6 million) of the total exports in May 2023 as seen in table 2.

The top five trading partners for exported goods in the May 2023 accounted 66.6 percent of the total value of exported goods. Major export destination was Pakistan that accounted 20.1 percent (TZS 905.5 million) of the total export in May 2023 (Figure 1).

4. Imports Statistics

May 2023 recorded a total import value of TZS 124,844.2 million, which increased by 46.7 percent compared to May 2022 and by 7.9 percent compared to previous month.

Mineral fuels, lubricants and related materials section 33.6 percent (TZS 41,954.1 million) of the total value imported followed by Machinery and transport equipment (26.5 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

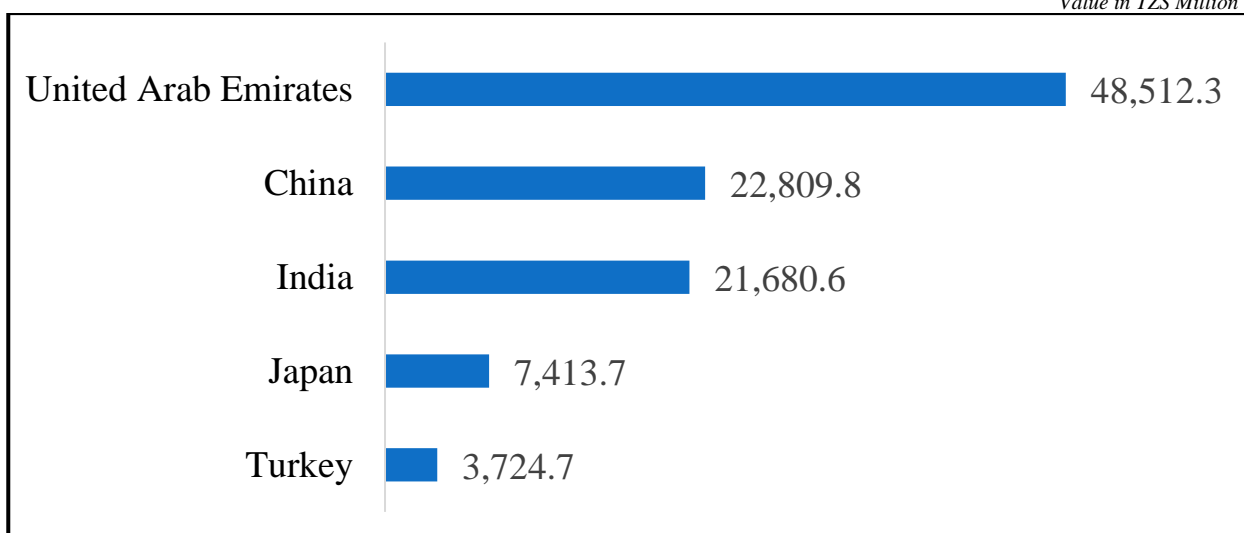
Imported value of consumer goods for May 2023 was TZS 29,246.5 million which increased by 92.8 percent compared to corresponding month and decreased by 37.7 percent compared to previous month. Imports value of capital goods was TZS 40,590.0 million which increased by 95.8 percent compared to the corresponding month and by 91.9 percent compared to the previous month. Imported value of intermediary goods was TZS 55,007.7 million which increased by 11.8 percent compared to the corresponding month of 2022 and by 15.5 percent compared to previous month. (Table 4).
