**1. Balance of Trade**

Balance of Trade showed a deficit of TZS 128,587.1 million in November 2022, increased by 58.1 percent compared to the corresponding month of 2021 and by more than hundred percent compared with the previous month. Trade ratio decreased from 28.7 percent in October 2022 to 21.6 percent in November 2022. (Table 1).

November 2022, recorded a total exports value of TZS 35,486.5 million, increased by 87.1 percent compared to November 2021 and by 44.1 percent compared with the previous month. Food and live animals section contributed 92.1 percent (TZS 32,698.9 million) of the total exports in November 2022 (table 2).



### 3. Exports by Top Five Partner in November 2022

The top five trading partners for exported goods in the November 2022 accounted 89.5 percent of the total value of exported goods. Major export destination was Indonesia that accounted 55.3 percent (TZS 19,621.3 million) of the total export in November 2022 (Figure 1).

### 4. Imports Statistics

November 2022 recorded a total import value of TZS 164,073.6 million, which increased by 63.6 percent compared to November 2021 and by 91.5 percent compared to previous month.

Mineral fuels, lubricants and related materials section contributed 41.5 percent (TZS 68,057.1 million) of the total value imported followed by Manufactured goods classified chiefly by material (15.1 percent). The performances of other sections are as shown in table 3.

## 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for November 2022 was TZS 47,723.0 million which increased by 96.2 percent compared to corresponding month and by more than hundred percent compared to previous month. Imports value of capital goods was TZS 35,415.2 million which increased by 92.4 percent compared to the corresponding month and by 97.2 percent compared to the previous month. Imported value of intermediary goods was TZS 80,935.3 million which increased by 40.6 percent compared to the corresponding month of 2021 and by 76.1 percent compared to previous month. (Table 4).


