## **MONTHLY EXTERNAL MERCHANDISE TRADE STATISTICS**

**MARCH 2020**

### **1. Balance of Trade**

Balance of Trade showed a deficit of TZS 88,633.8 million in March 2020, higher by 50.9 percent than the previous month and by 88.1 percent compared to the corresponding month of 2019.

### **2. Exports Statistics**

In March 2020, total exports decreased by 72.6 percent compared to previous month and increased by 57.4 percent compared to March 2019. In March 2020, food and live animals section contributed 97.0 percent of the total exports (table 2).

### 3. Exports by Top Ten Partner in March 2020

The top ten trading partners for exported goods in the March 2020 accounted 99.0 percent of the total value of exported goods. Major export destinations were India (41.9 percent) and Denmark (23.3 percent).

### 4. Imports Statistics

In March 2020, total imports increased by 24.0 percent compared to February 2020 and by 86.3 percent compared to March 2019. In March 2020, Machinery and transport equipment section

contributed (31.6 percent) of the total imports followed by mineral fuels, lubricants and related materials section contributed (26.8 percent) and food and live animals (17.3 percent). The performance of other sections is as shown in table 4.

## 5. Imports by Top Ten Partner in March 2020

The top ten trading partners for imported goods in the March 2020 contributed 90.4 percent of the total import. Imports were mainly from United Arab Emirates (30.5 percent), Germany (19.5 percent) and China (17.0 percent).
