MONTHLY EXTERNAL MERCHANDISE TRADE STATISTICS

MARCH 2022

1. Balance of Trade

Balance of Trade showed a deficit of TZS 87,902.7million in March 2022, increased by 8.6 percent compared to the corresponding month of 2021 and decreased by 3.8 percent compared with the previous month. Trade ratio increased from 8.2 percent in February 2022 to 19.2 percent in March 2022. (Table 1).

2. Exports Statistics

March 2022 recorded a total exports value of TZS 20,951.0 million, increased by more than hundred percent compared with corresponding month of 2021 and previous month. Miscellaneous manufactured articles section contributed 78.7 percent (TZS 16,495.5 million) of the total exports in March 2022(table 2).

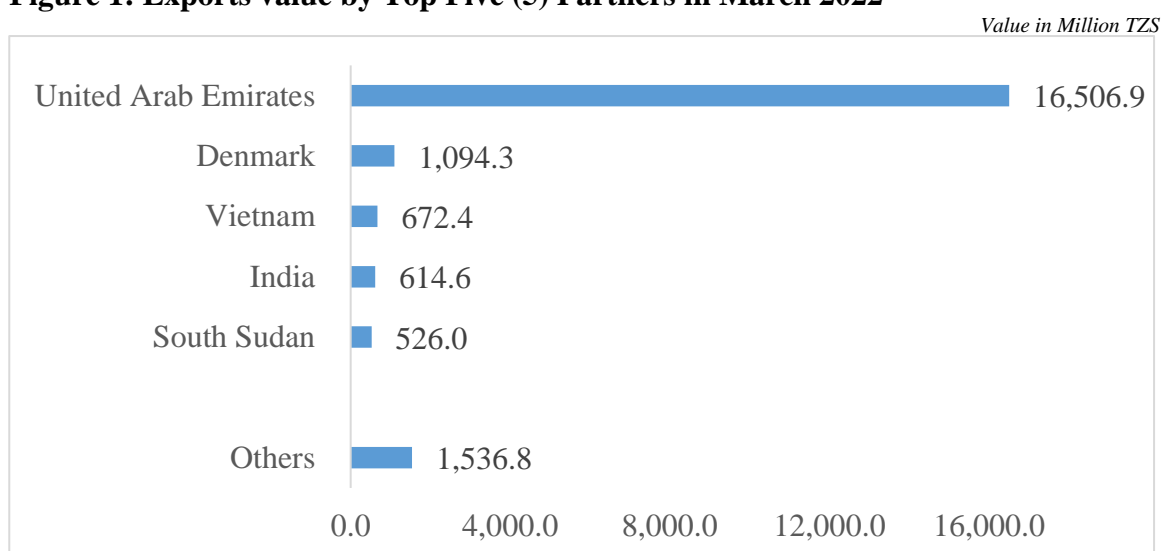

3. Exports by Top Five Partner in March 2022

The top five trading partners for exported goods in the March 2022 accounted 92.7 percent of the total value of exported goods. Major export destination was United Arab Emirates that accounted 78.8 percent (TZS 16,506.9 million) of the total export in March 2022(Figure 1).

4. Imports Statistics

March 2022 recorded a total import value of TZS 108,853.7 million, which increased by 28.9 percent compared to March 2021 and by 9.3 percent compared to previous month.

Mineral fuels, lubricants and related materials section contributed 43.1 percent (TZS 46,873.3 million) of the total value imported followed by Food and live animals (21.7 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for March 2022 was TZS 35,631.7 million which increased by 52.5 percent compared to the corresponding month of 2021 and by 20.1 percent compared to previous month.

Imports value of capital goods was TZS 15,165.5 million which increased by 26.9 percent compared to the corresponding month and decreased by 42.9 percent compared to the previous month.

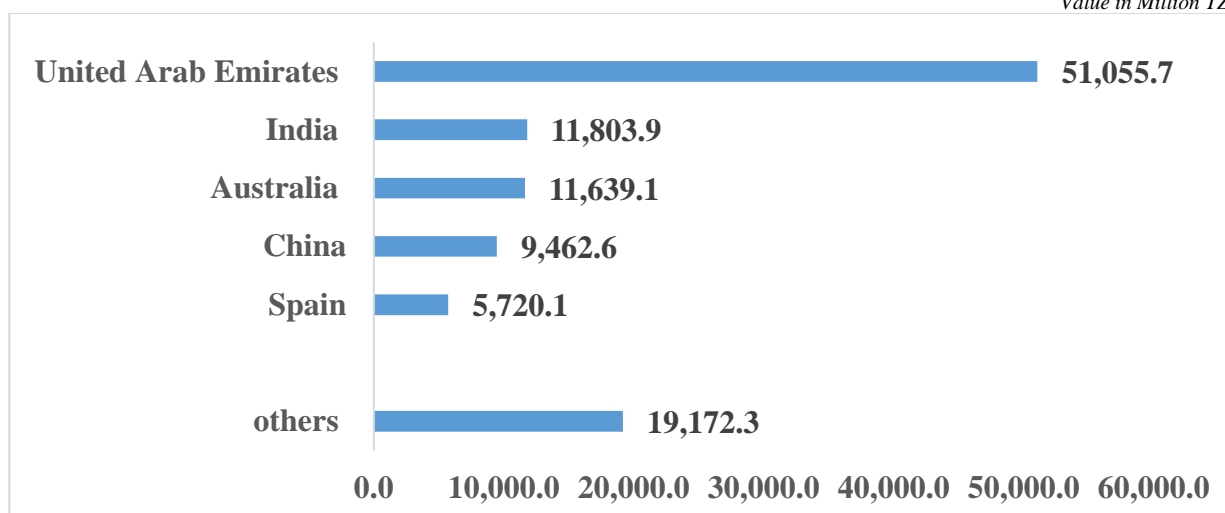
Imported value of intermediary goods was TZS 58,056.6 million which increased by 18.1 percent compared to corresponding month and by 33.9 percent compared to previous month (Table 4).
