1. Balance of Trade

Balance of Trade showed a deficit of TZS 118,416.7 million in January 2024, decreased by 0.1 percent compared to the corresponding month of 2023 and increased by 4.6 percent compared to the previous month. Trade ratio increased by 12.4 percent from 6.9 percent compared to the corresponding and 10.8 percent compared to the previous month. (Table 1).

2. Exports Statistics

January 2024, recorded a total exports value of TZS 16,791.5 million, increased by 92.1 percent compared to January 2023 and by 22.5 percent compared to previous month (December 2023). Food and live animals contributed 96.1 percent (TZS 16,130.4 million) of the total exports as seen in table 2.

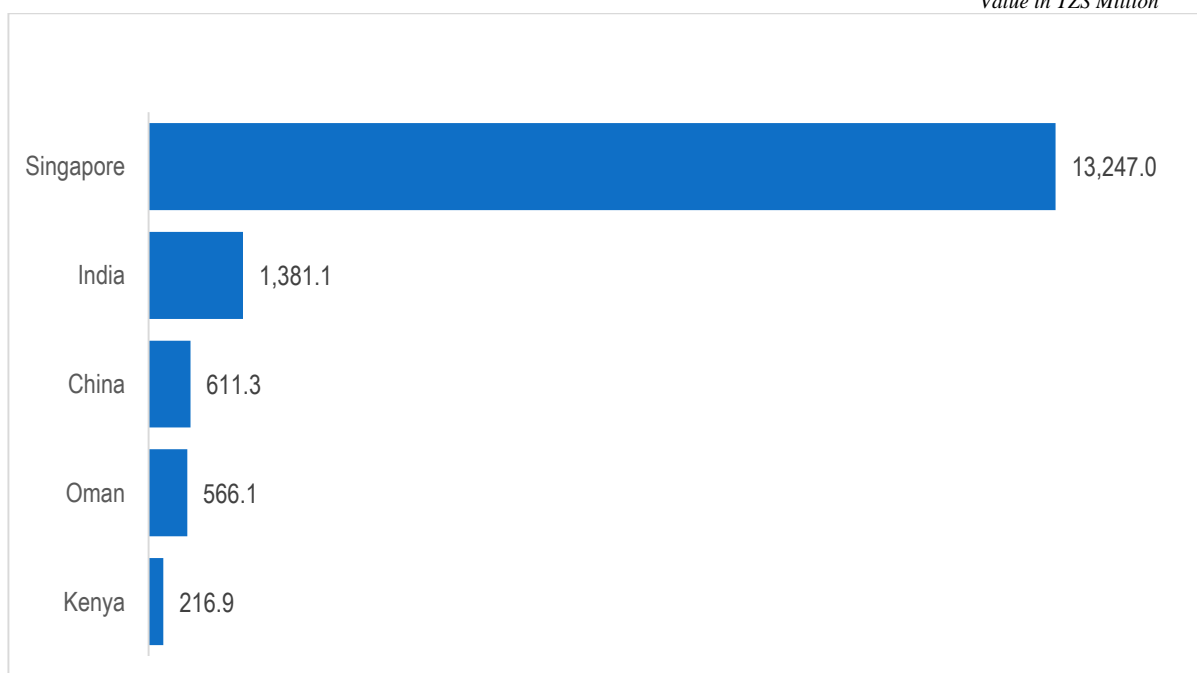

3. Exports by Top Five Partner in January 2024

The top five trading partners for exported goods in the January 2024 accounted 95.4 percent of the total value of exported goods. Major export destination was Singapore that accounted 78.9 percent (TZS 13,247.0 million) of the total export (Figure 1).

4. Imports Statistics

Month of January 2024 recorded a total import value of TZS 135,208.2, which increased by 6.2 percent compared to January 2023 and by 6.5 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 48.4 percent (TZS 65,430.3 million) of the total import value followed by Food and live animals section (17.4 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for January 2023 was TZS 36,818.0 million, which increased by 34.9 percent compared to corresponding month and by 10.5 percent compared to previous month. Imports value of capital goods was TZS 21,830.4 million, which increased by 24.0 percent compared with the corresponding month and by 34.9 percent compared with the previous month. Imported value of intermediary goods was TZS 76,559.7 million, which decreased by 7.0 percent compared to the corresponding month of 2023 and by 1.1 percent compared to previous month. (Table 4).

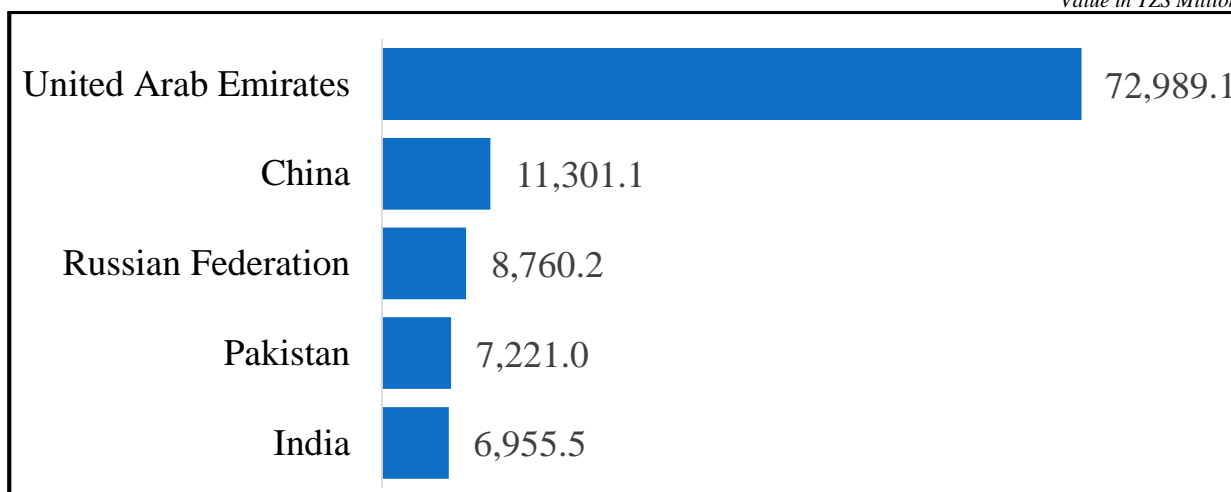
