## 1. Balance of Trade

Balance of Trade showed a deficit of TZS 80,969.0 million in March 2021, decreased by 8.6 percent compared to the corresponding month of 2020 and by 6.7 percent compared with the previous month. (Table 1).

### 2. Exports Statistics

March 2021 recorded a total exports value of TZS 3,505.9 million, decreased by 21.9 percent compared to March 2020 and by 16.1 percent compared to previous month. Food and live animals section contributed 66.5 percent (TZS 2,332.7 million) of the total exports in March 2021 (table 2).





### 3. Exports by Top Five Partner in March 2021

The top five trading partners for exported goods in the March 2021 accounted 75.7 percent of the total value of exported goods. Major export destination was South Africa that accounted 29.9 percent (TZS 1,047.5 million) of the total export in March 2021(Figure 1).

#### 4. Imports Statistics

March 2021 recorded a total import value of TZS 84,474.8 million, which decreased by 9.3 percent compared to March 2020 and by 7.2 percent compared to previous month. Mineral fuels, lubricants and related materials section contributed 43.1 percent (TZS 36,417.5 million) of the total value imported followed by manufactured goods classified chiefly by material (13.7 percent). The performances of other sections are as shown in table 4.

## 5. Import by Broad Economic Categories (BEC)


March 2021 imported value of consumer goods was TZS 23,362.2 million which increased by 4.1 percent compared to March 2020 and by 29.7 percent compared to previous month. Imports value of capital goods was TZS 11,952.6 million which decreased by 69.5 compared with corresponding month of 2020 and by 68.1 percent compared to the previous month and Imported value of intermediary goods was TZS 49,160.1 million which increased by 56.3 percent compared to corresponding month of 2020 and by 38.6 percent compared to previous month (Table 5).



#### 6. Imports by Top Five Partner in March 2021

The top five trading partners for imported goods in the March 2021 contributed 75.3 percent of the total import. Imports were mainly from United Arab Emirates (48.3 percent, TZS 40,809.9 million) and China (13.8 percent, TZS 11,648.1 million).
