1. Balance of Trade

Balance of Trade showed a deficit of TZS 125,526.5 million in May 2024, increased by 4.3 percent compared to the corresponding month of 2023 and decreased by 2.4 percent compared to the previous month. Trade ratio for May 2024 is 3.8, increased from 3.6 percent in April 2023 and from 3.5 percent for previous month. (Table 1).

2. Exports Statistics

May 2024, recorded a total exports value of TZS 4,988.7 million, increased by 10.5 percent compared to May 2023 and by 6.7 percent compared to previous month (April 2024). Food and live animals contributed 71.7 percent (TZS 3,577.6 million) of the total exports as seen in table 2.

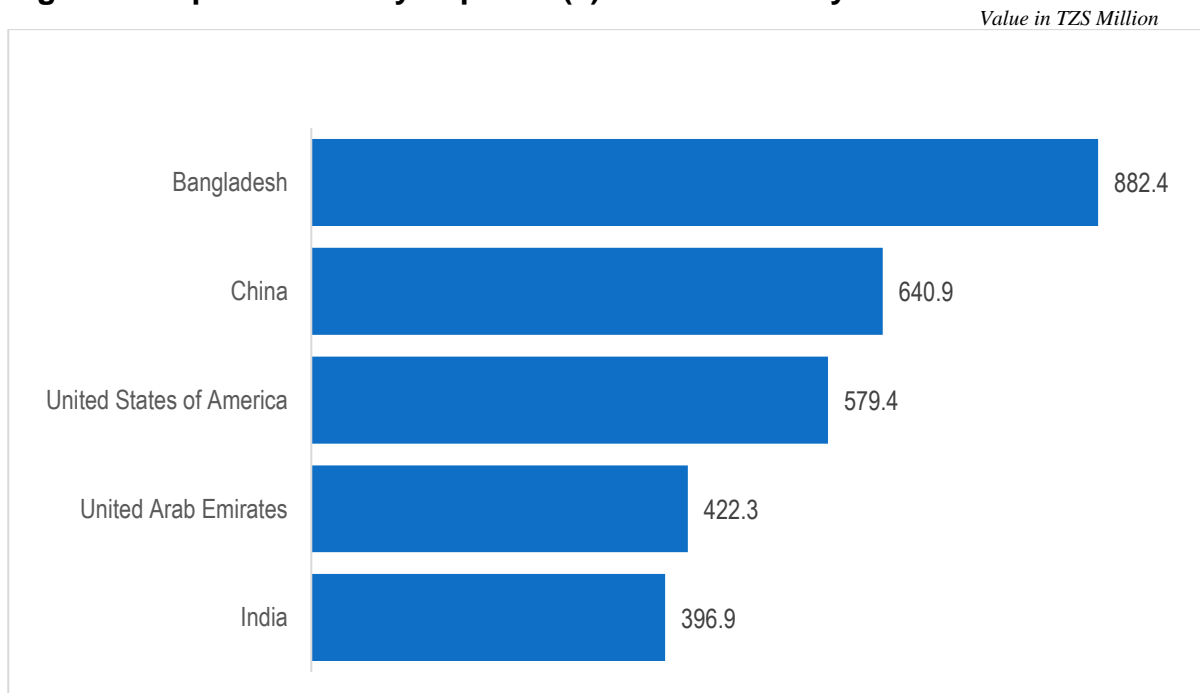

3. Exports by Top Five Partner in May 2024

The top five trading partners for exported goods in the May 2024 accounted 58.6 percent of the total value of exported goods. Major export destination was Bangladesh that accounted 17.7 percent (TZS 882.4 million) of the total export (Figure 1).

4. Imports Statistics

Month of May 2024 recorded a total import value of TZS 130,515.1 which increased by 4.5 percent compared to May 2023 and decreased by 2.0 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 46.6 percent (TZS 60,849.7 million) of the total import value followed Food and live animals section (20.3 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for May 2023 was TZS 39,918.5 million, which increased by 36.5 percent compared to corresponding month and by 30.3 percent compared to previous month. Imports value of capital goods was TZS 22,603.4 million, which decreased by 44.3 percent compared with the corresponding month and increased by 42.5 percent compared with the previous month. Imported value of intermediary goods was TZS 67,993.3 million, which increased by 23.6 percent compared to the corresponding month of 2023 and decreased by 21.6 percent compared to previous month. 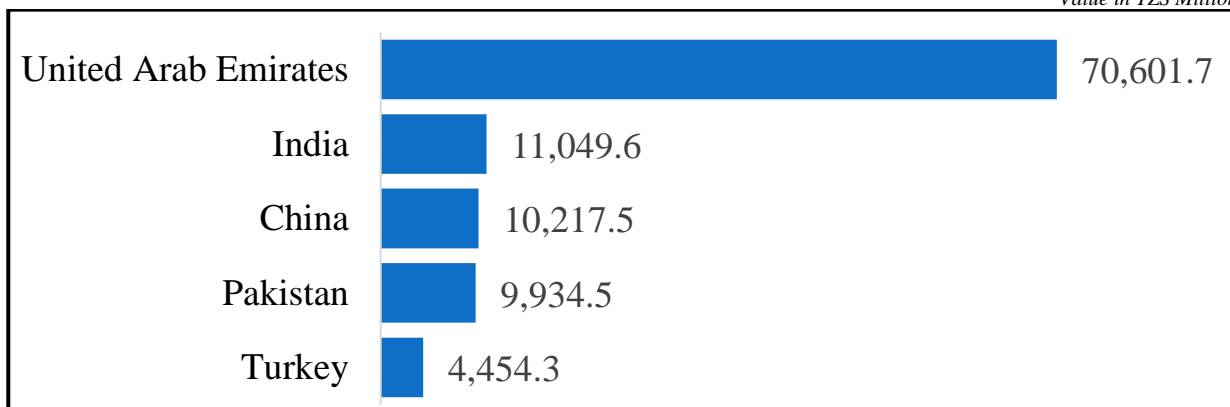

6. Imports by Top Five Partner in May 2024

The top five trading partners for imported goods in the May 2024 contributed 81.4 percent of the total import. Imports were mainly from United Arab Emirates (54.1 percent, TZS 70,601.7 million).
