1. Balance of Trade

Balance of Trade showed a deficit of TZS 64,348.5 million in July 2021, decreased by 39.4 percent compared to the corresponding month of 2020 and by 9.0 percent compared with the previous month. Trade ratio increased from 2.6 percent in June 2021 to 3.6 percent in July 2021. (Table 1).

2. Exports Statistics

July 2021 recorded a total exports value of TZS 2,430.1 million, decreased by 46.4 percent compared to July 2020 and increased by 27.7 percent compared to previous month. Food and live animals section contributed 64.8 percent (TZS 1,573.6 million) of the total exports in July 2021 (table2).



3. Exports by Top Five Partner in July 2021

The top five trading partners for exported goods in the July 2021 accounted 86.4 percent of the total value of exported goods. Major export destination was China that accounted 25.9 percent (TZS 629.1 million) of the total export in July 2021(Figure 1).

4. Imports Statistics

July 2021 recorded a total import value of TZS 66,778.6 million, which decreased by 39.7 percent compared to July 2020 and by 8.1 percent compared to previous month.

Mineral fuels, lubricants and related materials section contributed 40.4 percent (TZS 26,950.1 million) of the total value imported followed by Food and live animals (20.1 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for July 2021 was TZS 25,524.7 million which increased by 60.0 percent corresponding month (July 2020) and by 3.1 percent compared to previous month.

Imports value of capital goods was TZS 10,645.0 million which decreased by 85.1 with corresponding month of 2020 and by 48.3 percent compared to the previous month.

Imported value of intermediary goods was TZS 30,608.8 million which increased by 32.3 percent compared to corresponding month of 2020 and by 12.1 percent compared to previous month (Table 4).



6. Imports by Top Five Partner in July 2021

The top five trading partners for imported goods in the July 2021 contributed 76.5 percent of the total import. Imports were mainly from United Arab Emirates (45.1 percent, TZS 30,106.9 million).
