### 1. Balance of Trade

Balance of Trade showed a deficit of TZS 133,584.1 million in July 2024, decreased by 14.2 percent compared to the corresponding month of 2023 and increased by 11.4 percent compared to the previous month. Trade ratio increased from 3.5 percent in June 2024 to 5.3 percent in July 2024. (Table 1).

#### 2. Exports Statistics

July 2024, recorded a total exports value of TZS 7,543.9 million, increased by 4.3 percent compared to July 2023 and by 73.2 percent compared to previous month (June 2024). Manufactured goods classified chiefly by material contributed 74.5 percent (TZS 4,720.7 million) of the total exports as seen in table 2.



### 3. Exports by Top Five Partner in July 2024

The top five trading partners for exported goods in the July 2024 accounted 91.4 percent of the total value of exported goods. Major export destination was Oman that accounted 73.0 percent (TZS 5,505.0 million) of the total export (Figure 1).

#### 4. Imports Statistics

Month of July 2024 recorded a total import value of TZS 141,128.1 million, which decreased by 13.4 percent compared to July 2023 and increased by 13.6 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 44.4 percent (TZS 62,648.1 million) of the total import value followed by Machinery and transport equipment section (23.0 percent). The performances of other sections are as shown in table 3.

#### 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for July 2024 was TZS 25,089.7 million, which decreased by 53.9 percent compared to corresponding month and by 29.0 percent compared to previous month. Imports value of capital goods was TZS 41,107.3 million, which decreased by 29.3 percent compared to the both corresponding and increased by 24.5 percent compared the previous month. Imported value of intermediary goods was TZS 74,931.0 million, which increased by 48.6 percent compared to the corresponding month of 2023 and by 34.2 percent compared to previous month. (Table 4).


