1. Balance of Trade

Balance of Trade showed a deficit of TZS 149,205.7 million in August 2024, increased by 36.3 percent compared to the corresponding month of 2023 and increased by 11.7 percent compared to the previous month. Trade ratio decreased from 2.3 percent in August 2024 to 5.3 percent in July 2024. (Table 1).

2. Exports Statistics

August 2024, recorded a total exports value of TZS 3,540.5 million, decreased by 43.0 percent compared to August 2023 and by 53.1 percent compared to previous month (July 2024). Food and live animals contributed 80.9 percent (TZS 2,803.3 million) of the total exports as seen in table 2.

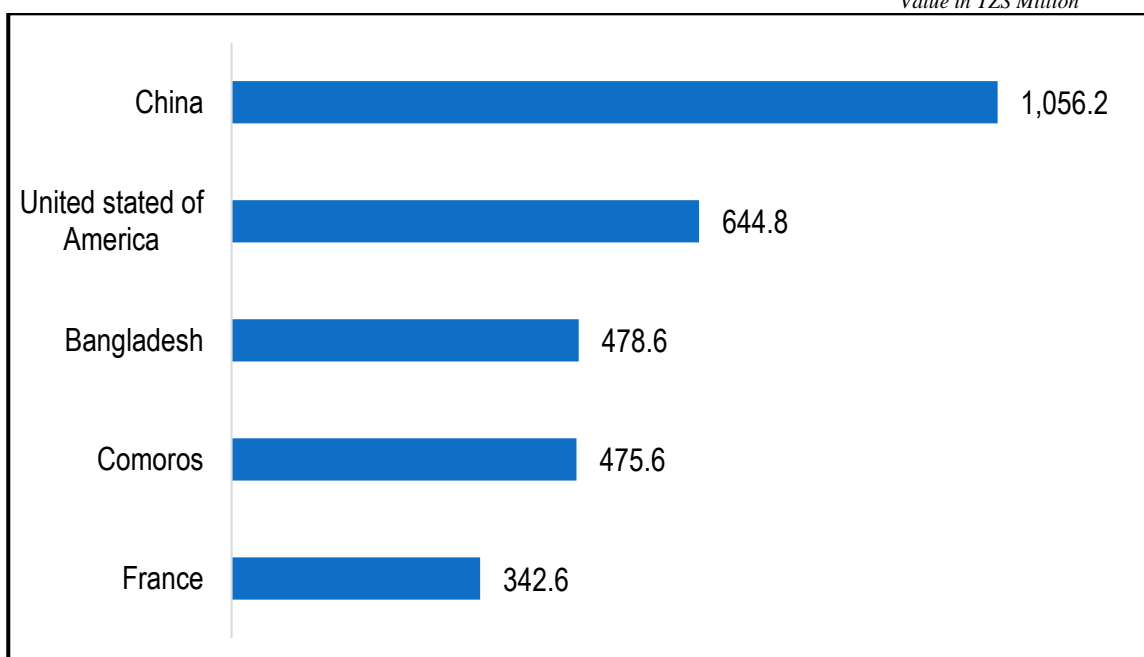

3. Exports by Top Five Partner in August 2024

The top five trading partners for exported goods in the August 2024 accounted 68.8 percent of the total value of exported goods. Major export destination was China that accounted 24.2 percent (TZS 1,056,2 million) of the total export (Figure 1).

4. Imports Statistics

Month of August 2024 recorded a total import value of TZS 152,746.2 million, which increased by 32.0 percent compared to August 2023 and increased by 8.2 percent compared to previous month. Food and live animals contribute 62.1 percent (TZS 94,790.5 million) of the total import value followed by Manufactured goods classified chiefly by material section (11.8 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for August 2024 was TZS 35,341.7 million, which increased by 12.1 percent compared to corresponding month and by 40.9 percent compared to previous month. Imports value of capital goods was TZS 42,057.0 million, which increased by 99.6 percent compared to corresponding month and by 2.4 percent compared the previous month. Imported value of intermediary goods was TZS 75,345.6 million, which increased by 19.4 percent compared to the corresponding month of 2023 and by 0.6 percent compared to previous month. (Table 4).

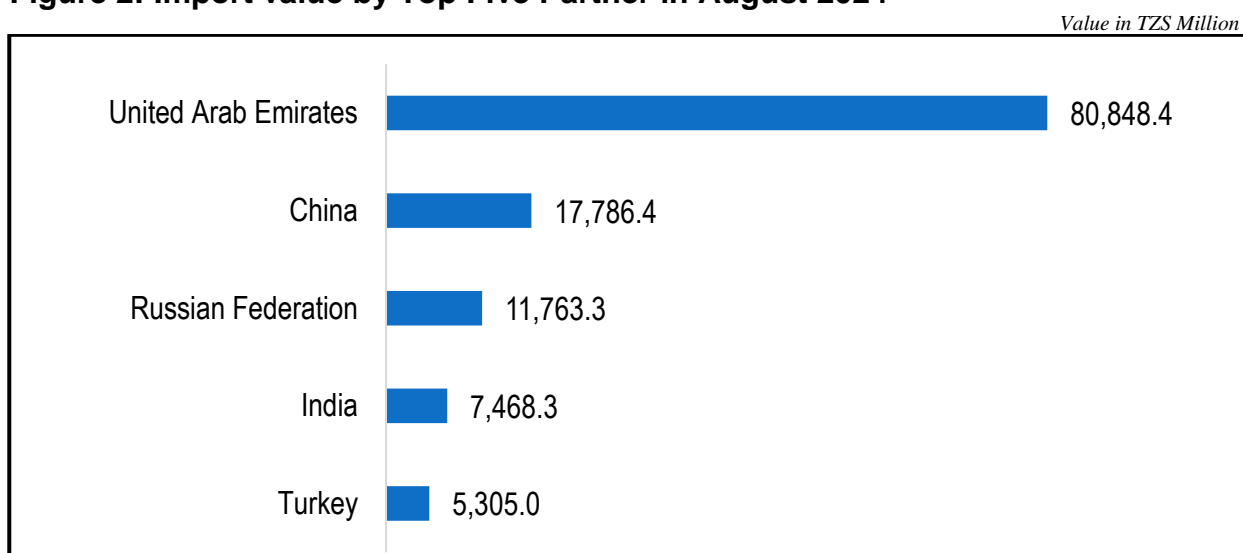
