1. Balance of Trade

Balance of Trade showed a deficit of TZS 109,301.5 million in September 2024, decreased by 17.6 percent compared to the corresponding month of 2023 and by 26.7 percent compared to the previous month. The trade ratio for September 2024 increased to 6.9 from 2.4 percent in August and decreased from 13.1 percent in the corresponding month of 2023. (Table 1).

2. Exports Statistics

September 2024, recorded a total export value of TZS 8,127.5 million, decreased by 59.4 percent compared to September 2023, and increased more than hundred percent compared to the previous month (August 2024). Food and live animals contributed 83.1 percent (TZS 6,751.2 million) of the total exports as seen in Table 2.



3. Exports by Top Five Partners in September 2024

The top five trading partners for exported goods in September 2024 accounted for 80.4 percent of the total value. The major export destination was India which accounted for 50.2 percent (TZS 4,082.7 million) of the total export (Figure 1).

4. Imports Statistics

The month of September 2024 recorded a total import value of TZS 117,429.0 which decreased by 23.1 percent compared to September 2023 and by 22.1 percent compared to the previous month. Mineral fuels, lubricants, and related materials contribute 48.3 percent (TZS 56,707.3 million) of the total import value followed by Machinery and transport equipment section (15.3 percent). The performances of other sections are as shown in Table 3.

5. Import by Broad Economic Categories (BEC)

The imported value of consumer goods for September 2024 was TZS 24,433.1 million, which decreased by 23.1 percent compared to the corresponding month of 2023 and by 38.0 percent compared to the previous month. Imports value of capital goods was TZS 25,785.1 million, which decreased by 57.1 percent compared with the corresponding month 2023 and by 6.5 percent compared with the previous month. The imported value of intermediary goods was TZS 67,210.7 million, which increased by 10.7 percent compared to the corresponding month of 2023 and decreased by 19.7 percent compared to the previous month. 
