1. Balance of Trade

Balance of Trade showed a deficit of TZS 111,242.7 million in November 2023, decreased by 13.5 percent compared to the corresponding month of 2022 and by 9.0 percent compared to the previous month. Trade ratio decreased from 10.9 percent in October 2023 to 9.5 percent in November 2023. (Table 1).

2. Exports Statistics

November 2023, recorded a total exports value of TZS 11,727.0 million, decreased by 67.0 percent compared to November 2022 and by 21.8 percent compared to previous month (October 2023). Food and live animals contributed 79.5 percent (TZS 9,324.4 million) of the total exports as seen in table 2.

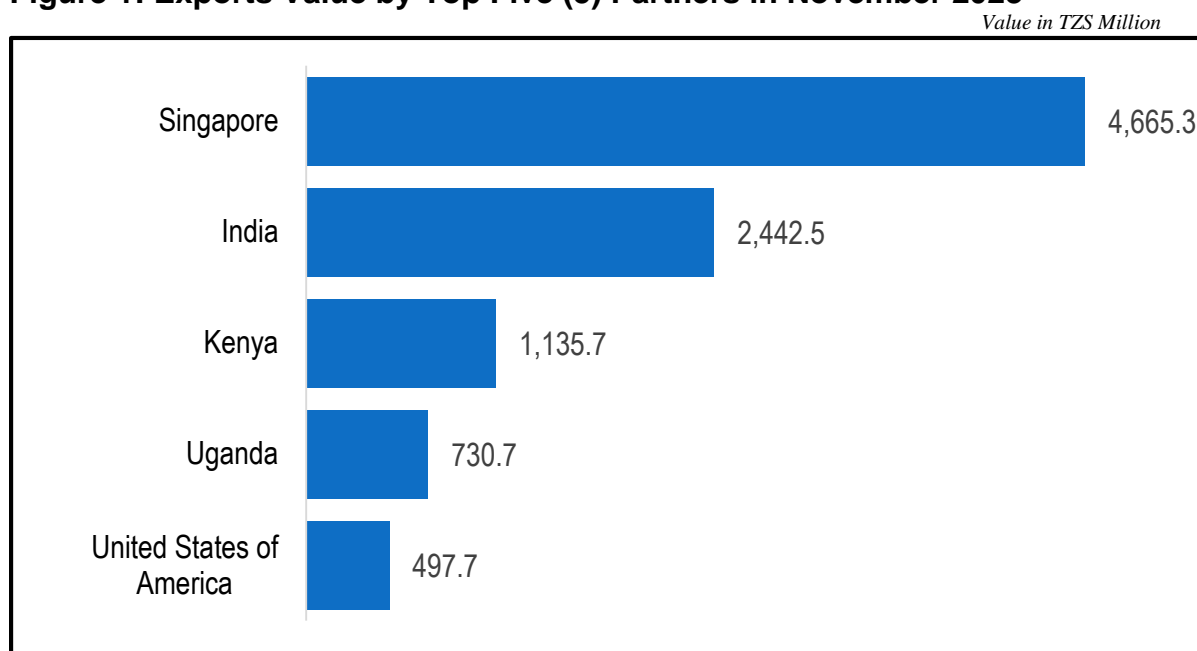

3. Exports by Top Five Partner in November 2023

The top five trading partners for exported goods in the November 2023 accounted 80.8 percent of the total value of exported goods. Major export destination was Singapore that accounted 39.8 percent (TZS 4,665.3 million) of the total export (Figure 1).

4. Imports Statistics

Month of November 2023 recorded a total import value of TZS 122,969.7, which decreased by 25.1 percent compared to November 2022 and by 10.4 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 64.1 percent (TZS 78,837.0 million) of the total import value followed by Machinery and transport equipment section (10.8 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for November 2023 was TZS 15,793.2 million, which decreased by 66.9 percent compared to corresponding month and by 55.8 percent compared to previous month. Imports value of capital goods was TZS 17,758.6 million, which decreased by 49.9 percent compared with the corresponding month and by 17.4 percent compared with the previous month. Imported value of intermediary goods was TZS 89,417.9 million, which increased by 10.5 percent compared to the corresponding month of 2022 and by 11.8 percent compared to previous month. (Table 4)

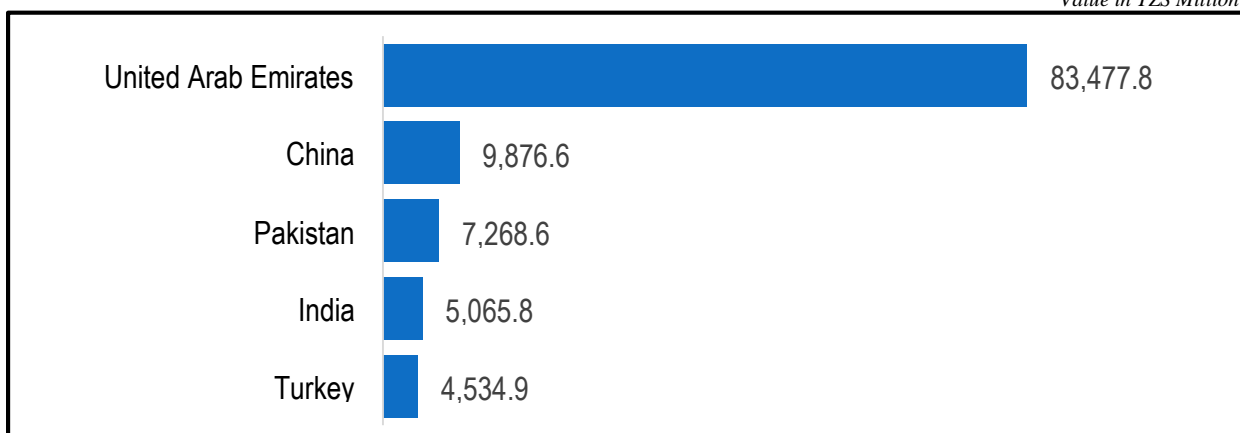
