### 1. Balance of Trade

Balance of Trade showed a deficit of TZS 153,509.0 million in December 2024, increased by 35.6 percent compared to the corresponding month of 2023 and by 3.6 percent compared to the previous month. The trade ratio for December 2024 decreased to 3.6 from 6.8 percent in November and increased from 10.8 percent in the corresponding month of 2023 (Table 1).

### 2. Exports Statistics

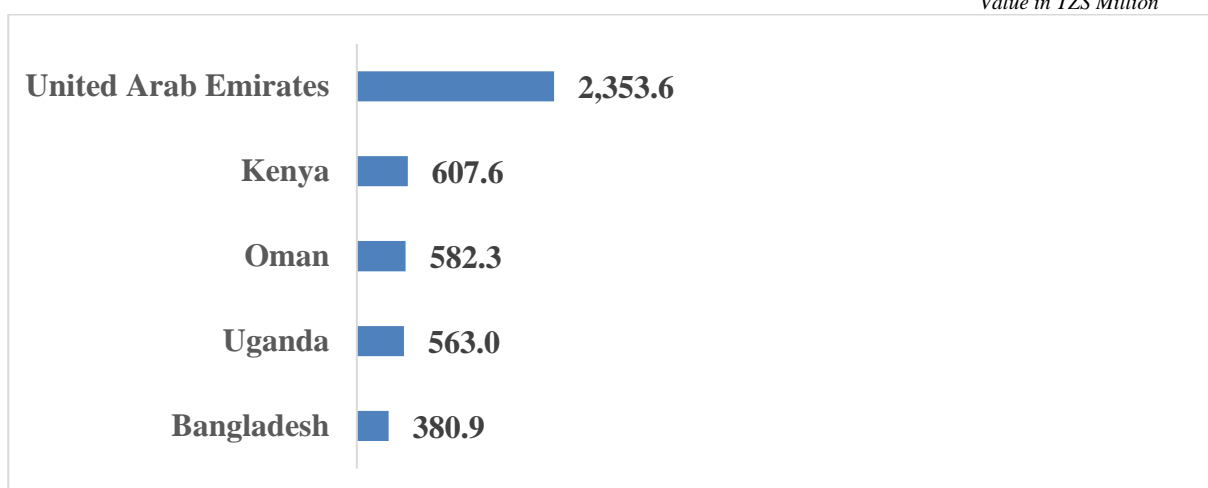
December 2024, recorded a total exports value of TZS 5,716.1 million, decreased by 58.3 percent compared to December 2023 and by 46.8 percent compared to previous month (November 2024). Miscellaneous manufactured articles contributed 42.7 percent (TZS 2,439.9 million) of the total exports as seen in table 2.

The top five trading partners for exported goods in the December 2024 accounted 78.5 percent of the total value of exported goods. Major export destination was United Arab Emirates that accounted 41.2 percent (TZS 2,353.6 million) of the total export (Figure 1).

## 4. Imports Statistics

Month of December 2024 recorded a total import value of TZS 159,225.1 million, which increased by 25.4 percent compared to December 2023 and increased by 0.2 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 40.4 percent (TZS 64,269.4 million) of the total import value followed by Machinery and transport equipment section (15.5 percent). The performances of other sections are as shown in table 3.

## 5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for December 2024 was TZS 43,535.6 million, which increased by 30.7 percent compared to the corresponding month and increased by 43.5 percent compared to previous month. Imports value of capital goods was TZS 38,942.6 million, which increased more than hundred percent compared corresponding month and decreased by 28.3 percent compared the previous month. Imported value of intermediary goods was TZS 76,746.8 million, which decreased by 0.9 percent compared to the corresponding month of 2023 and increased by 3.4 percent compared to previous month. 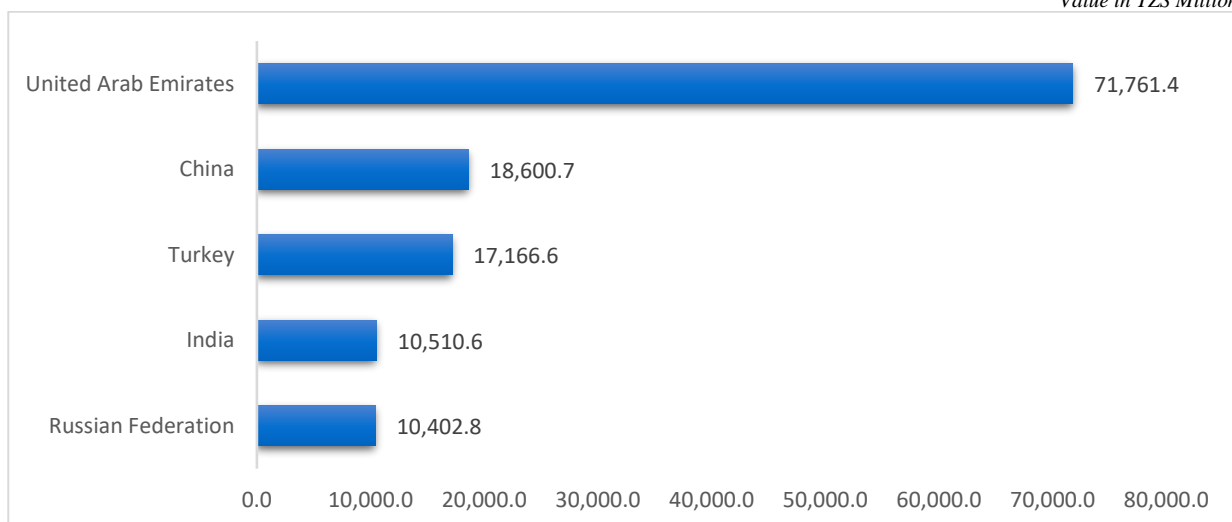
