

1. External Trade Performance.

Total trade for the fourth quarter, 2021 reached to TZS 323,927.4 million; in which exports value worth TZS 40,469.7 million (domestic export contributes TZS 35,567.1 million and reexport contributes 4,902.6 TZS million) and import worth TZS 283,457.7 million. The trade balance showed a deficit of TZS 242,988.0 Million (Table 1; figure 1).



The trend indicates that, total exports increased by more than hundred percent compared with corresponding quarter and decreased by 59.2 percent compared with previous quarter. Imports value increased by 50.2 percent compared with corresponding quarter and by 20.2 compared by previous quarter (Figure 2).




2. Exports Statistics

2.1. Exports by SITC section

The value of exports includes 'Export of goods for direct home use, Re-export after outright importation, Re-export after temporary import of goods on hire purchase and re-export after customers warehousing procedure.


In the fourth quarter of 2021, food and live animals section contributed 81.1 percent of the total exports followed by Miscellaneous manufactured articles (11.7 percent). (Figure 3 and table 2).




2.2. Exports of Main Cash Crops

A total of 4,140.3 tons, valued at TZS 3,806.6 Million of Seaweeds have exported in the fourth quarter of 2021, showing an increasing value by more than hundred percent compared with the corresponding quarter of 2020 and by 30.3 percent compared with the previous quarter (Figure 5 and table 3).

Exports of Seaweeds contributed 9.4 percent of the total export value, which have exported on about six countries as shown in figure 4.



A total of 1,467.4 tons, valued at TZS 24,691.0 Millions of Cloves were exported in the fourth quarter of 2021, the value has increased by more than hundred percent compared with corresponding quarter and decreased by 72.8 percent compared with previous quarter (figure 5 and table 3).



2.3. Exports by Top Five Countries of Destination


Figure 6: Distribution of Exports Value by Top Five Countries of Destination, Q4, 2021

The top five trading partners for exported goods in the fourth quarter of 2021 were Singapore, India, Spain, Vietnam and United States of America with a total value of TZS 33,247.0 million that accounted 82.2 percent of the total value of exported goods (Figure 6).

3. Imports Statistics

The value of imports includes 'Importation for direct home use (duty and tax fully paid)', 'Importation by, or solely for use in Zanzibar' and other importation procedure (Excludes all transfer goods).

3.1. Imports by SITC Section

In the fourth quarter of 2021, Mineral fuels, lubricants and related materials contributed 31.4 percent and Manufactured goods classified chiefly by material contributed about 20.9 percent of the total import, the performance of other categories are as shown in figure 7 and table 6.



3.2. Import by Categories




Figure 8: Percent Distribution of Import Value by Broad Economic Categories, Q4, 2021.

In the fourth quarter, import of intermediate goods reached to TZS 144,901.1 million of total import (51.1 percent) while capital goods reached to TZS 66,695.1 million (23.5 percent) and import of consumer goods reached to TZS 71,861.5 million (25.4 per cent) (Figure 8 and table 7).





Figure 9: Import by Broad Economic Categories, Q4- 2020, Q3 & Q4 2021

The imported value of consumer, intermediary and capital goods for the fourth quarter increased by more than 100 percent compared with corresponding quarter and previous quarter. (Figure 9 and Table 7).

3.3. Imports of Basic Food


Rice, Sugar and Wheat flour are the main food consumed in Zanzibar. These foods imported from different markets worldwide. Import of rice for the fourth quarter of 2021 amounted to 13,233.8 tons, worth TZS 6,802.3 Million while import of sugar is about 4,976.3 tons (TZS 4,006.7 Million) and imported wheat flour is about 1,638.1 tons (TZS 740.9 Million).

Trend shows that imported value of rice decreased by 29.5 percent compared with corresponding and increased by more than hundred percent compared with previous quarter. Imported value of sugar increased by 4.9 percent compared with corresponding and decreased by 21.5 percent compared with previous quarter while imported value of wheat flour increased by more than hundred percent for both corresponding and previous quarter. 3.4. Imports by Country of Origin

The top ten trading partners for imported goods in the fourth quarter of 2021 contributed a value of TZS 241,756.9 million, equivalents to 85.3 percent of the total import. United Arab Emirates was the top by accounting 35.7 percent of the value of the imported goods. (Figure 11 and table 9).



4. Transferred goods




Figure 12: Percentage Distribution of Transferred Goods from Zanzibar to Tanzania Mainland




Figure 13: Transferred Goods from Zanzibar to Tanzania Mainland, Q4, 2020, Q3 & Q4, 2021

A total of goods worth TZS 7,711.5 Million transferred to Tanzania Mainland from Zanzibar in the fourth quarter of 2021(Figure 13). Percentage transferred of goods shows that 27.8 percent (TZS 2,146.9 Million) of the total value of transferred goods were Animals and vegetable oils, fats & waxes while 24.8 percent (TZS 1,912.1 million) were Machinery and transport equipment. Manufactured goods classified chiefly by material were 19.8 percent (TZS 1,525.2 Million). Food and live animals were 13.3 percent (TZS 1,024.5 Million). The performance of other transferred goods are as shown in figure 12 and Table 10.

The trend shows that value of transferred goods to Tanzania Mainland from Zanzibar for the fourth guarter increased by more than hundred percent compared with the corresponding quarter and decreased by 3.2 percent compared with the previous quarter of 2021. (Figure 13 and Table 10).
