1. External Trade Performance.




Figure 1: Trade Performance for the Q3, 2020

Total trade for the third quarter, 2020 reached to TZS 279,434.3 million; in which exports value worth TZS 9,501.0 million (domestic export contributes TZS 6,398.3 million and reexport contributes 3,102.7 TZS million) and import worth TZS 269,933.3 million. The trade deficit reached to TZS 260,432.3 Million (Table 1; figure 1).

The trend indicates that, total exports decreased by 35.2 percent compared with corresponding quarter of 2019 and increased by 27 percent compared with previous quarter. The decreasing of export value in this quarter compared with preceding quarter is due to low exportation of cloves in this season. Imports value increased by 37.2 percent and 84.7 compared with corresponding quarter of 2019 and previous quarter respectively.




Figure 2: Trend Performance of Export and Import, Q3, 2019 – Q2 and Q3, 2020

2. Exports Statistics

2.1. Exports by SITC section

The value of exports includes 'Export of goods for direct home use, Re-export after outright importation, Re-export after temporary import of goods on hire purchase and re-export after customers warehousing procedure.




Figure 3: Percentage Distribution of Exports by SITC Section, Q3 2020

In the third quarter of 2020, food and live animals section contributed 56.5 percent of the total exports followed by crude materials, inedible, except fuels (31.3 percent) and Chemicals & related products, not elsewhere specify section (4.3 percent) (Figure 3 and table 2).

2.2. Exports of Main Cash Crops





Figure 4: Exports of Seaweeds by Countries of Destination, Q3, 2020




Figure 6: Distribution of Exports Value by Top Three Countries of Destination, Q3, 2020

A total of 2,962.2 tons, valued at TZS 2,916.4 Million of Seaweeds were exported in the third quarter of 2020, showing an increase value of 8.8 percent compared with the corresponding quarter of 2019 and decreased by 9.6 percent compared with the previous quarter (Figure 4 and 6). Exports of Seaweeds that contributed 30.7 percent of the total value exported to six (6) countries as shown in figure 4.

A total of 50.0 tons, valued at TZS 594.4 Million of Cloves exported in the third quarter of 2020, the value has decreased four times compared with corresponding quarter of 2019 and twice compared with the previous quarter. Exports of Cloves that contributed 6.3 percent of the total value exported to India.





2.3. Exports by Top Three Country of Destination




Figure 7: Percentage Distributions of Imports by SITC Section, Q3, 2020.

The top three trading partners for exported goods in the third quarter of 2020 were Cuba, Denmark and Vietnam with a total value of TZS 5,120.2 million that accounted 53.9 percent of the total value of exported goods (Figure 7).

3. Imports Statistics

The value of imports includes 'Importation for direct home use (duty and tax fully paid)', 'Importation by, or solely for use in Zanzibar' and other importation procedure (Excludes all transfer goods).

3.1. Imports by SITC Section




Figure 8: Percent Distribution of Import Value by Categories, Q3, 2020.

In the third quarter of 2020, Machinery and transport equipment contributed 44.1 percent and Mineral fuels, lubricants and related materials contributed about 21.9 percent of the total import, the performance of other categories are as shown in figure 8 and table 6.

3.2. Import by Categories




Figure 9: Import by Categories, Q3, 2019 – Q2 and Q3, 2020.

In quarter three import of intermediate goods reached to TZS 79,113.4 million of total import (29.3 percent) while capital goods reached to TZS 140,174.8 million (51.9 percent) and import of consumer goods for the third quarter of 2020 reached to TZS 50,645.1 million (18.8 percent) (Figure 9 and table 7).




Figure 10: Imports of Rice, Sugar and Wheat Flour, Q3, 2019 - Q2 and Q3, 2020

The Imported value of consumer goods for the third quarter was lower by 5.4 percent and 20.2 percent than the corresponding and previous quarter respectively. Imports of capital goods has increased four times compared with corresponding quarter and twice compared to the previous quarter. Import of intermediary goods was lower by 27.2 percent and by higher by 64.6 percent than the corresponding quarter and previous quarter respectively (Figure 10 and Table 7).

3.3. Imports of Basic Food

Rice, Sugar and Wheat flour are the main food consumed in Zanzibar. These foods imported from different markets worldwide. Import of rice for the third quarter of 2020 amounted to 22,363.8 tons equivalent to TZS 10,630.5 Million while import of sugar is about 6,496.0 tons (TZS 2,280.0 Million) and imported wheat flour is about 2,247.5 tons (TZS 1,088.9 Million).

Trend shows that imported value of rice increased by 15.2 percent compared with the previous quarter, imported value of sugar decreased by 39.6 percent compared with previous quarter and imported value of wheat flour decreased by 48.8 percent compared with the previous quarter of 2019. 3.4. Imports by Country of Origin

The top ten trading partners for imported goods in the third quarter of 2020 contributed a value of TZS 257,951.8 million, equivalents to 95.6 percent of the total import. China was the top by accounting 50.3 percent of the value of the imported goods. (Figure 12 and table 9).





Figure 11: Distribution of TOP Ten Imports by Countries of Origin Q3, 2020

4. Transferred goods


A total of goods worth TZS 4,740.2 Million transferred to Tanzania Mainland from Zanzibar in the third quarter of 2020. Figure 13 shows that 38.1 percent (TZS 1,807.3 Million) of the total value of transferred goods were machinery and transport equipment; while 32.6 percent (TZS 1,544.9 Million) were Food and live animals; the performance of other transferred goods are as shown in figure 13 and Table 10.

The trend shows that value of transferred goods decreased by 5.3 percent compared with the corresponding quarter and 39.8 percent compared with previous quarter. (Figure 14 and Table 10).
