1. Trade Performance.




Figure 1: Trade Performance for the Q1, 2020

Total trade for the first quarter, 2020 reached to TZS 282,416.3 million; in which exports value worth TZS 39,882.8 million (domestic export contributes TZS 39,789.9 million and reexport contributes 92.9 TZS million) and import worth TZS 242,533.5 million. The trade deficit reached to TZS 202,650.7 Million (Table 1; figure 1).

The trend indicates that, total exports increased by TZS 34,496.5 million and TZS 20,762.3 million compared with corresponding quarter of 2019 and previous quarter respectively. The increasing of export value in this quarter compared with preceding quarter is due to high exportation of cloves in this season. Imports value increased by TZS 83,638.6 million (52.6 percent) from TZS 158,894.9 million recorded in corresponding quarter of 2019 as well as increased by TZS 21,561.6 TZS Million (9.8 percent) compared with TZS 220,971.9 million recorded in previous quarter of 2019.




Figure 2: Trend Performance of Export and Import, Q1 2019 - Q1, 2020

2. Exports Statistics

3.1 Exports by SITC section

The value of exports includes 'Export of goods for direct home use, Re-export after outright importation, Re-export after temporary import of goods on hire purchase and re-export after customers warehousing procedure.

In the first quarter of 2020, food and live animals section contributed 98.5 percent of the total exports followed by manufactured goods classified chiefly by material section and crude materials, inedible, except fuels that contribute 0.4 percent each (Figure 3 and table 2).

3.2 Exports of Main Cash Crops




Figure 4: Exported value of Seaweeds by Countries of Destination, Q1, 2020





Figure 6: The value Trend of Exported cloves and Seaweeds, Q1, 2019 - Q1, 2020

A total of 3,733.9 tons, valued at TZS 4,001.2 Million of Seaweeds were exported in the first quarter of 2020, showing an increase value of 34.3 percent compared with the corresponding quarter of 2019 and an increase of 76.3 percent compared with the previous quarter (Figure 4 and 6). Exports of Seaweeds that contributed 10.0 percent of the total value exported to four (4) countries as shown in figure 4.

A total of 3,114.2 tons, valued at TZS 33,722.5 Million of Cloves exported in the first quarter of 2020, increased value by TZS 19,304.60 Million compared with previous quarter of 2019. Exports of Cloves to six (6) countries contributed 84.6 percent of the total exported value as shown in figure 5.

Figure 5: Exported value of cloves by Countries of Destination, Q1, 2020

3.3 Exports by Top Three Country of Destination




Figure 7: Distribution of Exports Value by Top Three Countries of Destination, Q1, 2020

The top three trading partners for exported goods in the first quarter of 2020 were India, Singapore, and Denmark with a total value of TZS 35,051.0 million that accounted 89.7 percent of the total value of exported goods (Figure 7). Cloves were major commodity exported to these countries.


3. Imports Statistics

The value of imports includes 'Importation for direct home use (duty and tax fully paid)', 'Importation by, or solely for use in Zanzibar' and other importation procedure (Excludes all transfer goods).

4.1 Imports by SITC Section

In the first quarter of 2020, Mineral fuels, lubricants and related materials contributed about 33.6 percent of the total import while Machinery and transport equipment contributed 24.1 percent, the performance of other categories are as shown in figure 8 and table 6.

4.2 Import by Categories

Data on Figure 9 and table 7 shows that import of intermediate goods reached to TZS 100,068.5 million of total import (41.3 percent) while capital goods reached to TZS 79,506.5 million (32.8 percent) and import of consumer goods for the first quarter of 2020 reached to TZS 62,958.5 million (26.0 percent).





Figure 10: Imported value by Categories, Q1, 2019 - Q1, 2020.

The Imported value of consumer goods for the first quarter was higher by 73.8 percent and 21.5 percent than the corresponding and previous quarter respectively. Import of capital

goods was higher by 43.3 percent than the previous quarter. Import of intermediary goods was higher by 3.7 percent than the corresponding quarter and lower by 12.0 percent than the previous quarter (Figure 10 and Table 7).

4.3 Imports of Basic Food

Rice, Sugar and Wheat flour are the main food consumed in Zanzibar. These foods imported from different markets worldwide. Import of rice for the first quarter of 2020 amounted to 43,899.2 tons equivalent to TZS 20,528.1 Million while import of sugar is about 7,102.0 tons (TZS 2,819.2 Million) and imported wheat flour is about 2,050.5 tons (TZS 852.5 Million).


Figure 11: Imported value of Rice, Sugar and Wheat Flour, Q1, 2019 - Q1, 2020

Trend shows that imported value of rice increased by 41.7 percent compared with the corresponding quarter, imported value of sugar decreased by 1.1 percent compared with previous quarter and imported value of wheat flour decreased by 29.7 percent compared with the corresponding quarter and 32.4 percent compared with the previous quarter (Figure 11 and Table 8).

4.4 Imports by Country of Origin

The top ten trading partners for imported goods in the first quarter of 2020 contributed a value of TZS 223,614.6 million, equivalents to 92.2 percent of the total import. United Arab Emirates was the top by accounting 36.7 percent of the value of the imported goods. (Figure 12 and table 9).

4. Transferred goods





Figure 13: Percentage Distribution of Transferred Goods from Zanzibar to Tanzania Mainland by SITC Section, Q1, 2020

A total of goods worth TZS 3,688.7 Million transferred to Tanzania Mainland from Zanzibar in the first quarter of 2020. Figure 13 shows that 44.8 percent (TZS 1,654.2 Million) of the total value of transferred goods were machinery and transport equipment; while 29.8 percent (TZS 1,100.9 Million) were Food and live animals; the performance of other transferred goods are as shown in figure 13 and Table 10.

The trend shows that value of transferred goods decreased by 54.6 percent compared with the corresponding quarter and 31.6 percent compared with previous quarter. (Figure 14 and Table 10).
