

1. Introduction

The Report of External Merchandise Statistics is the Fourth quarter (October-December) report for the 2023 year produced by Office of the Chief Government Statistician (OCGS). The report shows current situation for the Fourth quarter of 2023 and the trends of international trade between Zanzibar and the Rest of the World (RoW) for the period of corresponding Fourth quarter (October-December) of 2022 and previous second Quarter (July-September) of 2023.

2. External Trade Performance.

Total trade for the Fourth quarter, 2023 reached to TZS 427,514.9 million; in which exports value worth TZS 40,423.5 million (domestic export contributes TZS 40,415.5 million and re-export contributes 8.1 TZS million) and import worth TZS 387,091.3 million. The trade balance showed a deficit of TZS 346,667.8 million (Table 1 and figure 1).



The trend indicates that, total exports decreased by 42.0 percent compared with corresponding quarter of 2022 and increased by 20.9 percent compared with previous quarter. Imports value increased by 10.5 percent compared with corresponding quarter of 2022 and decreased by 10.3 percent compared with previous quarter (Figure 2).

3. Exports Statistics

Exports by SITC section

3.1. The value of exports includes 'Export of goods for direct home use, Re-export after outright importation, Re-export after temporary import of goods on hire purchase and re-export after customers warehousing procedure.






Figure 3: Percentage Distribution of Exports by SITC Section, Q4 - 2023

In the Fourth quarter of 2023, food and live animals section contributed 88 percent of the total exports followed Manufactured goods classified chiefly by material (9 percent) as shown in Figure 3 and table 2.


Exports of Main Cash Crops

A total of 1,673.0 tons, valued at TZS 29,940.6 millions of cloves have been exported in the Fourth quarter of 2023, showing decreasing value by 46.2 percent compared with corresponding quarter of 2022 and increased more than hundred percent 3.2 compared with the previous quarter (Figure 6, table 3). Exports of cloves contributed 74.1 percent of the total export value, which have been exported to four (4) countries as shown in figure 4.



A total of 2,297.1 tons, valued at TZS 3,707.3 million of Seaweeds were exported in the Fourth quarter of 2023, decreasing value by 11.5 percent compared with the corresponding quarter of 2022 and by 36.4 percent compared with the previous quarter (Figure 6, table 3). Exports of Seaweeds contributed 9.4 percent of the total export value, which have been exported to eight (8) countries as shown in figure 5.

The top ten trading partners for exported goods in the Fourth quarter of 2023 accounted 96.6 percent of the total value of exported goods. Singapore was the leading exporting




Figure 7: Distribution of Exports Value by Top Ten Countries of Destination, Q4-2023

partner (57.3 percent) followed by India which contributed 17.9 percent (Figure 7 and table 4).

4. Imports Statistics

The value of imports includes 'Importation for direct home use (duty and tax fully paid)', 'Importation by, or solely for use in Zanzibar' and other importation procedure 4.1. (Excludes all transfer goods).

Imports by SITC Section




Figure 8: Percentage Distributions of Imports by SITC Section, Q4-2023.

In the Fourth quarter of 2023, Mineral fuels, lubricants and related materials contributed 56.7 percent while beverage and tobacco contributed 0.2 percent of the total import, the performance of other categories is as shown in figure 8 and table 6.

Import by Categories

4.2.




Figure 9: Percent Distribution of Import Value by Broad Economic

In the Fourth quarter of 2023, import of intermediate goods reached to TZS 246,818.6 million of total import (64 percent) while import of consumer goods reached to TZS 84,823.5 million (22 percent) and capital goods reached to TZS 55,449.2 million (14 percent) (Figure 9 and table 7).

The results show the imported value of intermediary goods for the Fourth quarter of 2023 increased by 37.0 percent compared with corresponding quarter of 2022 and by 41.6 percent compared with previous quarter. Import of consumer goods decreased by 14.5 percent and 27.9 percent compared with corresponding guarter of 2022 and previous quarter respectively while import of capital goods decreased by 21.9 percent and by 60.2 percent compared with corresponding guarter of 2022 and previous quarter respectively. 4.3.





Figure 11: Percentage Distribution of Top Ten Imports by Countries of Origin

The top ten trading partners for imported goods in the Fourth guarter of 2023 contributed a value of TZS 366,982.2 million, equivalents to 94.8 percent of the total import. United Arab Emirates was the top by accounting 60.0 percent of the value of the imported goods. (Figure 11 and table 8).

5. Transferred goods

A total of goods worth TZS 80,014.10 million transferred to Tanzania Mainland from Zanzibar in the Fourth quarter of 2023 (Figure 12). About ninety eight (97.5 percent) of the total value of transferred goods were Machinery and transport equipment (TZS 78,028.00 million) while the lowest percent (TZS 0.02 million) were Beverages and tobacco. The performance of other transferred goods as shown in figure 12 and Table 8.

The value of transferred goods to Tanzania Mainland for the Fourth quarter increased by more than hundred percent compared with both, corresponding quarter of 2022 and previous quarter (Figure 13 and Table 9).

Figure 13: Transferred Goods from Zanzibar to Tanzania Mainland, Q4-2022, Q3 & Q4-2023


