1. Balance of Trade

Balance of Trade showed a deficit of TZS 109,508.1 million in August 2023, decreased by 1.6 percent compared to the corresponding month of 2022 and by 29.9 percent compared to the previous month. Trade ratio increased from 4.4 percent in July 2023 to 5.4 percent in August 2023. (Table 1).

2. Exports Statistics

August 2023, recorded a total exports value of TZS 6,211.0 million, decreased by 49.0 percent compared to August 2022 and by 14.1 percent compared to previous month (July 2023). Food and live animals contributed 60.2 percent (TZS 3,738.3 million) of the total exports as seen in table 2.



3. Exports by Top Five Partner in August 2023

The top five trading partners for exported goods in the August 2023 accounted 70.5 percent of the total value of exported goods. Major export destination was Denmark that accounted 19.6 percent (TZS 1,214.8 million) of the total export (Figure 1).

4. Imports Statistics

Month of August 2023 recorded a total import value of TZS 115,719.1 million, which decreased by 6.3 percent compared to August 2022 and by 29.0 percent compared to previous month. Mineral fuels, lubricants and related materials section contribute 49.4 percent (TZS 57,202.7 million) of the total import value followed by Food and live animals section (14.2 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for August 2023 was TZS 31,525.3 million, which decreased by 22.7 percent compared to corresponding month and by 42.0 percent compared to previous month. Imports value of capital goods was TZS 21,073.7 million, which increased by 31.0 percent compared to the corresponding and decreased by 63.7 percent compared with the previous month. Imported value of intermediary goods was TZS 63,120.2 million, which decreased by 5.3 percent compared to the corresponding month of 2022 and increased by 25.2 percent compared to previous month. 
