1. Balance of Trade

Balance of Trade showed a deficit of TZS 155,713.7 million in July 2023, increased by 87.1 percent compared to the corresponding month of 2022 and by 55.3 percent compared to the previous month. Trade ratio increased from 3.7 percent in June 2023 to 4.4 percent in July 2023. (Table 1).

2. Exports Statistics

July 2023, recorded a total exports value of TZS 7,234.0 million, increased by 61.9 percent compared to July 2022 and by 88.5 percent compared to previous month (June 2023). Food and live animals contributed 65.3 percent (TZS 4,720.7 million) of the total exports as seen in table 2.



3. Exports by Top Five Partner in July 2023

The top five trading partners for exported goods in the July 2023 accounted 67.3 percent of the total value of exported goods. Major export destination was Mozambique that accounted 24.2 percent (TZS 1,753.4 million) of the total export (Figure 1).

4. Imports Statistics

Month of July 2023 recorded a total import value of TZS 162,947.7 million, which increased by 85.9 percent compared to July 2022 and by 56.5 percent compared to previous month. Machinery and transport equipment section contribute 32.4 percent (TZS 52,721.0 million) of the total import value followed by Mineral fuels, lubricants and related materials section (26.8 percent). The performances of other sections are as shown in table 3.

5. Import by Broad Economic Categories (BEC)

Imported value of consumer goods for July 2023 was TZS 54,393.7 million, which increased by more than hundred percent compared to corresponding month and by 52.3 percent compared to previous month. Imports value of capital goods was TZS 58,122.8 million, which increased by more than hundred percent compared to the both corresponding and the previous month. Imported value of intermediary goods was TZS 50,431.2 million, which decreased by 17.5 percent compared to the corresponding month of 2022 and increased by 9.8 percent compared to previous month. 
